Please note that Leon County Animal Control Ordinance does not permit pets to roam freely. This pertains to dogs and cats. If you have a pet, please be sure to keep it on a leash.

This ordinance also requires that pet waste must be removed by the pet owner. Please be sure to carry a bag with you to dispose of pet waste properly.

Our neighborhood is designated as a no solicitation neighborhood and signs are clearly posted at each entrance. If a solicitor shows up at your door, please advise them that soliciting is prohibited in Lenox Mill. If they continue to solicit or you are suspicious of their intent, please notify law enforcement at 606-5800.

Property Modification Requests:

Before beginning any home additions or improvements please read the Lenox Mill Covenants and Restrictions document. **Your plans must be approved by the HOA Architectural Control Committee (ACC).**

This includes, but is not limited to:

- Exterior Paint Color
- Tree Removal
- New Roof Color/Material
- Construction of any free-standing structures
- Pool Additions
- Screen Enclosures
- Fences
- Irrigation Systems
